2.	Review minutes and actions from previous general meeting held on 16 April 2018 and moved to accept, motioned by Luciane Lauffer and seconded by Wayne Plant	CS
3.	Technical session from Frank Maiuolo who talked about denying obvious goal scoring opportunity, handball and positioning	FM
4.	Presentation from Alex Zhou about positioning – focused on several aspects of positioning for referees to adopt throughout a game	AZ
